**CRITERIA**

Eligibility:

Examples of those eligible for the distinguished service award are local, regional and state Family, Career and Community Leaders of America advisors, city and state supervisors of family and consumer sciences and family and consumer sciences educators.

Qualifications:

The contributions of the candidate to the Family, Career and Community Leaders of America programs should be outstanding or unique and in excess of regular duties in one or more of the following ways:

1. Helped to promote the goals of Family, Career and Community Leaders of America region-wide through:
  - providing outstanding services which contribute to the achievement of the Family, Career and Community Leaders of America goals;
  - promoting and supporting the regional organization through national leadership positions;
  - helping to develop new directions for the Family, Career and Community Leaders of America program in relation to needs of individuals and families in the changing society;
  - giving outstanding assistance which has helped develop or carry out Family, Career and Community Leaders of America projects on a regional, state or national level; and
  - conducting an effective public relations program which has helped interpret Family, Career and Community Leaders of America.
  
2. Rendered service to family and consumer sciences and the Family, Career and Community Leaders of America which has regional, state, and/or national implications such as:
  - authored publications of value to youth in working toward family and consumer sciences education and the Family, Career and Community Leaders of America's organization goals;
  - developed materials for interpreting the program of the Family, Career and Community Leaders of America;
  - developed materials and plans for helping teachers and prospective teachers to make the Family, Career and Community Leaders of America an integral part of family and consumer sciences education on a regional, state, and/or national level;
  - conducted significant research related to Family, Career and Community Leaders of America organization.
